



IN 2015, PROJECT CHIMPS (PC) BEGAN ITS SEARCH FOR A POTENTIAL CHIMPANZEE SANCTUARY PROPERTY TO PURCHASE. THE PERFECT PROPERTY WAS FOUND AND 186 ACRES IN NORTHERN GEORGIA WERE PURCHASED IN DECEMBER OF 2015. NOT ONLY IS THE LOCATION WONDERFUL FOR A CHIMPANZEE SANCTUARY, THE SITE ITSELF ALREADY INCLUDED MOST OF THE BUILDINGS A CHIMPANZEE SANCTUARY WOULD NEED: HOUSING VILLAS FOR CHIMP FAMILY GROUPS, A LARGER GROUP BUILDING SPACE PERFECT FOR CHIMPANZEE INTRODUCTIONS AND FAMILY GROUP FORMATIONS, SPACIOUS OUTDOOR AREAS, ADMINISTRATIVE OFFICES, MEAL PREP/CHIMP KITCHEN, STAFF LOCKER ROOMS, VETERINARY CLINIC, AND MORE. THESE 14 BUILDINGS AND OTHER PROPERTY ON THE LAND WERE DONATED TO PC FOR USE IN THE RESCUE AND CARE OF CHIMPANZEES.


